New executive structure at Erbe

The range of tasks performed by Erbe Elektromedizin has increased continuously over time, and in the past few years the Group has grown constantly at an average rate of 8%. The reorganization of company management announced in February of this year was implemented on May 1st, upon the retirement of Reiner Thede.

At the end of April 2020, Managing Director Reiner Thede retired. He had managed the enterprise together with his brother-in-law Christian O. Erbe since 1996. The new five-member executive team has now taken up its duties as follows:

<u>Christian O. Erbe</u>, as Managing Partner and Chief Executive Officer, is in charge of determining the strategic orientation of the enterprise.

<u>Daniel Zimmermann</u>, as Chief Financial Officer for Finances, oversees Finances, Controlling, Personnel, IT, Purchasing, Logistics and Facility Management

<u>Marcus Felstead</u>, as Chief Marketing Officer, heads Marketing, Sales, Technical Services and New Business Development.

<u>Dr. Helmut Scherer</u>, as Chief Technology Officer, is responsible for the areas of Development, Quality and Approvals Management, Production and Industrial Property Rights.



<u>Prof. Dr. Markus Enderle</u>, as Chief Scientific & Medical Officer, supervises medical and scientific tasks. At the executive level he is responsible for research including basic development as well as preclinical and clinical medicine.

Together these five members will expand the culture of responsibility in all areas and departments in Germany and at our subsidiaries in Europe, Asia and the USA.
